

Epidemiological declaration form

Data processing agreement clause provided in relation to the announcement of epidemics

I, the undersigned declare the following:

- 1) I have read and I accept the provisions of the "NUTECH-2020 Registration Regulations";
- 2) I am not subjected to quarantine or I am not subjected to sanitary supervision;
- 3) In the period of 14 days prior to the participation in the conference NUTECH-2020 I have not had a direct contact with the following:
 - a.a person, who had a positive test for SARS-COV-2 coronavirus, causing the contagious disease COVID-19;
 - b.a person subjected to quarantine or isolation due to the above-mentioned viral infection;
 - c.a person, who had visible symptoms of disease or was exposed to a contact with an infected person;
- 4) During the past 14 days I have had no symptoms of disease, particularly increased body temperature, cough, respiratory problems;
- 5) I hereby give my consent to a body temperature measurement and a health check.

I hereby declare that in the event of a change of any of the particulars communicated under points 2 to 4 , I will not participate in the conference NUTECH-2020 or I will bring an end to my participation.

Pursuant to Article 13 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (hereinafter "the Regulation") we hereby inform you that the controller of your personal data shall be Mazurkas Travel Biuro Podróży Sp. z o.o.(limited liability company) based in w Warsaw, Al. Pursuant to Article 9 (2) (i) of the Regulation, in connection with Article 17 of the Law of 2 March 2020 on special arrangements connected with prevention, counteracting and fighting COVID-19, other contagious diseases as well as crisis situations caused by them (Journal of Laws 2020, item 374) and in connection with the guidelines of the Ministry of Development and the Supreme Sanitary Inspector for the organizers of business meetings, training courses, conferences and congresses during SARS- Co V- 2 virus epidemics (https://www.gov.pl/web/rozwoi/spotkania-biznesowe-szkolenia-konferencie-i-kongresy), I hereby agree to the processing of my personal data for the purposes of attaining the objective of protection of life and health of the Participants and Organizers of NUTECH-2020 conference, as well as for the protection from serious transborder health threats, considering the epidemics announced since 20 March 2020 on the territory of the Republic of Poland, which was caused by SARS-CoV-2 viral infections. SARS-CoV-2 is a source of a contagious disease.

The recipients of the data may include:

- a) Employees and associates of Institute of Nuclear Chemistry and Technology; Mazurkas Travel Biuro Podróży Sp. z o.o.
- b) The staff of relevant services and inspections;
- c) As well as competent government agencies.

I am aware that my submission of data is voluntary. The legal basis for data processing is my consent.

I have the right to withdraw my consent at any time, which shall not affect the lawfulness of processing based on consent given prior to its withdrawal. Personal data shall be processed within 21 days after the closing of NUTECH-2020 conference.

The provided personal data shall not be processed by automated means as well as they shall not be processed in the form of profiling. I am entitled to the following:

a) The right of access the content of the data; b) the right of rectification of data; c) the right to the erasure of data; d) the right to limit the processing of data; e) the right to object to the processing of data.

I also have the right to file a complaint to the supervisory authority.

Personal data shall not be transferred to a third country (outside the European Union or the European Economic Area) or to international organizations.
